STATUTORY SERVICES

(approved by the Minister for Economic Affairs)

1 Hallmarking charges including applying of the Netherland's fineness marks

Platinum

- used items € 14,50 per item

new items till weight limit of 0,5 grams € 1,30 per item

new items (from 0,5 grams) € 3,50 per item

For 1 pair of new earrings the item price x1,5 will be charged

For new items above 25 grams the item price x2 will be charged

Gold

- used items € 4,85 per item

new items till weight limit of 1 gram € 1,25 per item

new items (from 1 gram) 1 till 300 items in one shipment € 1,80 per item

new items (from 1 gram) 301 till 900 items in one shipment € 1,71 per item

new items (from 1 gram) 901 till 1.500 items in one shipment € 1,53 per item

new items (from 1 gram) more than 1.500 items in one shipment € 1,29 per item

For 1 pair of new earrings the item price x1,5 will be charged

For new items above 25 grams the item price x2 will be charged

Silver

- used items € 4,85 per item

new items till weight limit of 8 gram € 1,05 per item

new items (from 8 grams) 1 till 400 items in one shipment € 1,29 per item

new items (from 8 grams) 401 till 1.200 items in one shipment € 1,22 per item

new items (from 8 grams) 1.201 till 2.500 items in one shipment € 1,06 per item

new items (from 8 grams) more than 2.500 items in one shipment € 0,79 per item

For 1 pair of new earrings the item price x1,5 will be charged

For new items above 25 grams the item price x2 will be charged

Combined articles

Used items

Gold/silver € 7,25 per item

Gold/platinum or silver platinum € 16,60 per item

New items

Gold/silver, gold/platinum or silver/platinum € 4,85 per item

2 Hallmarking with Common Control Marks (CCM)

The same charges are applicable as for the Netherland's fineness marks, plus the charges for extra marks (see also under 3)

3 Applying (extra) marks

(for example: assay office mark, date lettermark, weight mark, extra fineness mark, responsibility mark etc.)

- Applying legal fineness mark € 0,00 per item

- Applying extra mark € 0,33 per item

- Applying responsibility mark Holland Assay Office € 0,66 per item

4 Application / registration of a new Responsibility Mark

Handling application € 99,50 p/application

5 Exemption-certificate for marking

Exemption-certificate (excluding charges for testing) € 41,75 per certificate

6 Charges for disapprovals

In proportion to the number of items and lots of a shipment

7 Charges for testing on legal fineness

per item € 4,85 per item

Applying of fineness mark per item on request

10 Charges for testing

Testing approximate of fineness, per item on request

12 Handling

Handling of packed articles, per item € 0,18

Separation on fineness/metal, per minute € 1,25

13 Minimum order charges

For each shipment a minimum charge of € 19,75 is applied (excl. Postal Charges, express service, direct service, package handling)

14 Express Service

Surcharge of 20% on the charges as indicated under 1, 2, 3, 6, 7, 8, 9, 10, 11 and 12 or if applicable on minimum order charges

15 Direct Service

Surcharge of 100% on the charges as indicated under 1, 2, 3, 6, 7, 8, 9, 10, 11 and 12 or if applicable on minimum order charges

16 Package and handling

Per shipment € 11,70

17 Traveling hours / external expertise

Per hour € 49,50

Per kilometer € 0,95

Expertise per hour € 85,00

18 Summary of Netherland's Hallmarks

Per piece € 1,00

19 Storage fees

1 month after finishing hallmarking, 1% over invoice amount per week or part thereof.
